### ASSIGNMENT OF A TRADEMARK

Assignor further sells, assigns, transfers and sets over to Assignee the right to apply for trademark registrations and domain name registrations and to sue and collect damages and/or profits for both past, present and future infringements of the Mark.

2. At any time, and from time to time after the date hereof, at Assignee's request, Assignor shall execute and deliver such other instruments of sale, transfer, conveyance, assignment and confirmation and take such other action at Assignee's expense as Assignee may reasonably deem necessary or desirable in order to more effectively transfer, convey and assign to Assignee and to confirm Assignee's title to the Mark and any and all trademark applications and registrations and domain name registrations therefor, and to assist Assignee in exercising all rights with respect thereto.

3. This Assignment shall be binding upon the parties, their successors, heirs, assigns, legal representatives and all others acting by, through, with or under their direction, and all those in privity therewith.
