TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT ("Assignment") is entered into by and between Infonox on the Web, a California corporation ("Assignor") and Total System Services, Inc., a Georgia corporation ("Assignee").

WHEREAS, Assignor is the owner of the trademarks and the registrations thereof with the U.S. Patent and Trademark Office listed in Schedule A hereto (the "Trademarks"); and

WHEREAS, in connection with that certain Agreement of Merger, dated as of November 3, 2008, by and among Assignor, Assignee, TSYS Merger Corp. and certain individuals as shareholder representatives, Assignor desires to assign to Assignee, and Assignee desires to accept such assignment of, the Trademarks pursuant to the terms and conditions of this Assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree as follows:

1. Assignment of Trademarks. Effective as of the date executed by Assignor, Assignor hereby assigns, transfers and conveys to Assignee, its successors, assigns, and legal representative, all of Assignor's right, title and interest in and to the Trademarks, including, without limitation, (i) the goodwill of the business symbolized by the Trademarks; (ii) all registrations and applications for registration of the Trademarks; and (iii) Assignor's right to sue for damages and other remedies against past, present and future infringement of the Trademarks.
2. Further Assurances. Assignor further agrees to execute all documents necessary to perfect such rights, title and interest in Assignee, its successors, assigns, and legal representatives.
3. Responsibilities of Assignee. Assignee shall be solely responsible for all cost and fees incurred in connection with recording this Assignment.
4. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the United States of America and the State of Georgia.
5. Successors and Assigns. This Assignment shall inure to the benefit of and be binding on the successors and assigns of both parties.



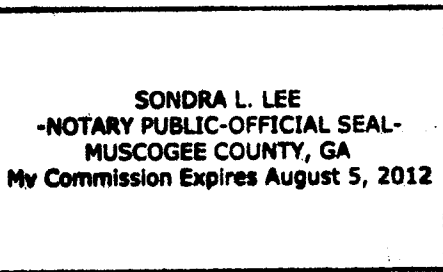
