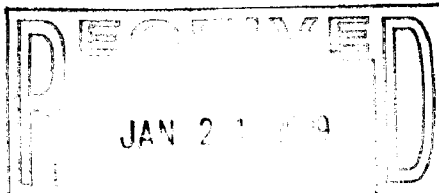

## RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated January 12, 2009 by BANK OF MONTREAL, a chartered bank of Canada acting through its Chicago branch (“*BMO*”) with its mailing address at 115 South LaSalle Street, Chicago, Illinois 60603, acting as agent for the various secured creditors as defined in that certain Trademark Collateral Agreement referred to below (BMO acting as administrative agent being hereinafter referred to as the “*Agent*”);

### WITNESSETH:

WHEREAS, the Agent and ISE America, Inc., a Delaware corporation (“*Debtor*”) with its principal place of business and mailing address at 33335 Galena Sassafras Rd., Galena, Maryland 21635 are parties to a certain Trademark Collateral Agreement dated December 18, 2006 which was recorded in the United States Patent and Trademark Office on December 26, 2006 at Reel 003450, Frame 0436, pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “*Trademarks*”); and

WHEREAS, the Debtor has requested that the Agent release its security interests in the Trademarks and reassign the same to the Debtor;

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
