**RELEASE OF SECURITY INTEREST**

WHEREAS, RTI Biologics, Inc. (formerly known as Regeneration Technologies, Inc.), a Delaware corporation (“RTI”), Regeneration Technologies, Inc. – Cardiovascular (formerly known as Alabama Tissue Center, Inc.), an Alabama corporation (“RTI-Cardiovascular”), RTI Services, Inc., a Delaware corporation (“RTI Services”), and Biological Recovery Group, Inc., a Delaware corporation (“BRG”, and together with RTI, RTI-Cardiovascular and RTI Services, collectively, “Assignee”), each with offices at 11601 Research Circle, Alachua, Florida, on March 23, 2004 granted a security interest in the federal trademark applications and registrations shown on the attached Schedule 1 (collectively, the “Marks”) to GE Business Financial Services Inc. 

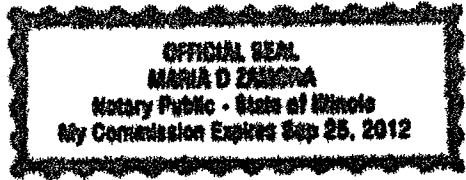
