TRADEMARK TRANSFER AGREEMENT

This Trademark Transfer Agreement ("Transfer Agreement") is made by and between Derm/Star, Inc., an Illinois corporation with a principal place of business at 229 Newcomb Road, Plainville, NY 11803 ("Corporation") and Medikit, LLC, a Delaware limited liability company with a principal place of business at 1 Clearland Road, Syosset, NY 11791 ("Company").

WHEREAS, Company and Corporation are parties to a certain Securities Purchase and Contribution Agreement with an effective date of 12/15/09, 2009 ("Purchase Agreement");

WHEREAS, Corporation is the owner of the following trademarks: US Registration No. 2859464 for the mark "EPI-KIT", and 3013817 for the mark "MSLECKIT" (collectively the "Marks");

WHEREAS, under the terms of the Purchase Agreement, Corporation has agreed to assign, transfer and deliver the Marks to the Company;

WHEREAS, Company wishes to acquire ownership of Marks; and

WHEREAS, Company is a successor to the business of Corporation to which the Marks pertain, which business is ongoing and existing;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Corporation hereby assigns to Company all right, title and interest in and to the Marks for the United States and throughout the world, together with the goodwill of the business associated therewith.

This Transfer Agreement includes all rights in the nature of trademark, service mark, and trade name rights, as well as the right to sue for past infringement of such rights by any third party.

Corporation agrees to execute any additional documents presented to Corporation by Company and to perform any other acts at the Company's expense which are or may be reasonably necessary to evidence or perfect the assignment, including those reasonably necessary to effectuate the recording of the assignment.
