WHEREAS, The Computer Center, a corporation of Maine, having an address of 370 U.S. Route One, Falmouth, Maine 04105 (hereinafter "ASSIGNOR"), had adopted and used in its business the trademark MUNIS which is duly registered in the United States Patent and Trademark Office ("PTO") as Registration No. 1,522,450, registered January 31, 1989; and

WHEREAS, ASSIGNEE at one time conducted business under the name Tyler Corporation;

WHEREAS, ASSIGNEE is desirous of acquiring and confirming the acquisition of all right, title and interest in and to said mark, said registration and said goodwill;


