TRADEMARK RELEASE OF SECURITY INTEREST

THIS TRADEMARK RELEASE OF SECURITY INTEREST is made as of December 19, 2008 by GE Business Financial Services Inc. (formerly known as Merrill Lynch Business Financial Services Inc.), as administrative agent ("Administrative Agent").

WITNESSETH:

WHEREAS, Administrative Agent and Celeste Industries Corporation, a Connecticut corporation ("Pledgor"), were parties to that certain Trademark Security Agreement, dated as of March 16, 2006 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Pledgor granted a security interest to Administrative Agent in, among other things, the Trademarks (as defined in the Security Agreement), as security for certain obligations owing by Pledgor to the financial institutions (collectively, "Lenders") from time to time party to that certain Credit Agreement, dated as of March 16, 2006, by and among Pledgor, Administrative Agent and Lenders, as amended, restated, supplemented or otherwise modified and in effect from time to time, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Security Agreement was recorded by the Assignment Division of the United States Patent and Trademark Office on April 11, 2006 at Reel 3286, Frame 0420; and

WHEREAS, Pledgor has requested that Administrative Agent release its security interest in the Trademarks and reassign the same to Pledgor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Administrative Agent hereby releases its security interest in all of Pledgor's right, title and interest in and to all of the following (the "Trademark Collateral"):

(a) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and


(b) all products and proceeds of the forgoing, including without limitation, any claim by Pledgor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Administrative Agent hereby reassigns, grants and conveys to Pledgor, without any representation, warranty, recourse or undertaking by Administrative Agent, all of Administrative Agent's right, title and interest in and to the Trademark Collateral, and the goodwill of Pledgor's business connected with the use of and symbolized by the Trademark Collateral.
