DISCHARGE OF RECORDED SECURITY INTEREST
(Trademarks of National Seating Comopany)

WHEREAS, by a Security Agreement (Trademarks) dated March 16, 2005 (the "Security Agreement") National Seating Company ("NCS") granted a security interest in the United States trademarks listed in Exhibit A attached hereto (the "Collateral") to U.S. Bank National Association, as Agent.
