DISCHARGE OF RECORDED SECURITY INTEREST

WHEREAS, by a Security Agreement (Trademarks) dated March 16, 2005 (the "Security Agreement") CVG Acquisition LLC (n/k/a Mayflower Vehicle Systems, LLC) ("CVG Acq/MVS") granted a security interest in the United States trademarks listed in Exhibit A attached hereto (the "Collateral") to U.S. Bank National Association, as Agent.
