DISCHARGE OF RECORDED SECURITY INTEREST
(Trademarks of Commercial Vehicle Systems, Inc./Sprague Devices, Inc.)

WHEREAS, by a Security Agreement (Trademarks) dated March 16, 2005 (the "Security Agreement") Commercial Vehicle Systems, Inc.(n/k/a Sprague Devices, Inc.) ("CVS/Sprague") granted a security interest in the United States trademarks listed in Exhibit A attached hereto (the "Collateral") to U.S. Bank National Association, as Agent.
