**DISCHARGE OF RECORDED SECURITY INTEREST**  
**(Trademarks of Trim Systems Operating Corp.)**

WHEREAS, by a Security Agreement (Trademarks) dated March 16, 2005 (the "Security Agreement") Trim Systems Operating Corp.
