## TRADEMARK ASSIGNMENT AGREEMENT

This Agreement is made as of January 1, 2009, ("Effective Date") by and between Operation Blessing International Relief and Development Corporation, a non-profit corporation, organized and existing under the laws of the state of Virginia, whose principal place of business is located at 977 Centerville Turnpike, Virginia Beach, Virginia 23463 ("OBI"), and The Christian Broadcasting Network, Inc., a non-profit corporation, organized and existing under the laws of the state of Virginia, whose principal place of business is located at 977 Centerville Turnpike, Virginia Beach, Virginia 23463 ("CBN").

WHEREAS, OBI is the owner of the U. S. Trademark "ORPHAN'S PROMISE" in International Class 36, Registration No. 3,259,830 ("Trademark") and

WHEREAS, it is the desire and intention of the parties that OBI assign to all right, title and interest in and to the Trademark worldwide ("Territory").

Now, therefore, in consideration of the above and other good and valuable consideration, the parties hereto hereby agree as follows:

1. Grant. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, OBI does hereby assign to CBN all right, title and interest in and to the Trademark worldwide, the goodwill of the business symbolized by said Trademark, along with the registration thereof.

2. Ownership. OBI confirms CBN's ownership of the Trademark and agrees not to take or cause any actions that would interfere with CBN's ownership, use, or registration thereof. All use by CBN of the Trademark will inure to the benefit of CBN. OBI shall not seek or obtain protection of any kind, including registration, of the Trademark. OBI MAKES NO REPRESENTATION OR WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, WITH RESPECT TO THE TRADEMARK.

3. Jurisdiction. This Agreement will be governed by and construed in accordance with the laws of the Commonwealth of Virginia, U.S.A.

4. Notice. All notices and communications in this Agreement will be in writing and will be considered given when personally delivered or mailed by prepaid certified or registered mail, return receipt requested, or by internationally recognized courier, such as Federal Express, or by facsimile with electronic confirmation to the parties at the respective addresses stated below. (or at such other address as either party may specify by notice given to the other):




