BILL OF SALE

Jasco hereby constitutes and appoints Buyer as the true and lawful agent and attorney in fact of Jasco, with full power of substitution and resubstitution, in whole or in part, in the name and stead of Jasco but on behalf of and for the benefit of Buyer and its successors and assigns, from time to time:

- (a) to demand, receive and collect any and all of the Subject Assets from any third party and to give receipts and releases for and with respect to the same, or any part thereof;
- (b) to institute and prosecute, in the name of Jasco or otherwise, any and all proceedings at law, in equity or otherwise, that Buyer or its successors and assigns may reasonably deem necessary or advisable in order to collect or reduce to possession any of the Subject Assets and in order to collect or enforce any claim or right of any kind hereby transferred or assigned; and
- (c) to do all things required or reasonably deemed by Buyer to be required to recover and collect the Subject Assets and to use Jasco's name in such manner as Buyer may reasonably deem necessary for the collection and recovery of same.


Nothing expressed or implied in this Bill of Sale is intended to confer upon any person, other than Buyer and its successors and assigns, any rights, remedies, obligations or liabilities under or by reason of this Bill of Sale.

The internal laws of Delaware shall govern the validity and interpretation of this Bill of Sale and the performance by the parties hereto of their respective duties and obligations hereunder.
