- (c) to do all things required or reasonably deemed by Buyer to be required to recover and collect the Subject Assets and to use PA's name in such manner as Buyer may reasonably deem necessary for the collection and recovery of same.


Nothing expressed or implied in this Bill of Sale is intended to confer upon any person, other than Buyer and its successors and assigns, any rights, remedies, obligations or liabilities under or by reason of this Bill of Sale.

The internal laws of Delaware shall govern the validity and interpretation of this Bill of Sale and the performance by the parties hereto of their respective duties and obligations hereunder.
