TRADEMARK ASSIGNMENT

TRADEMARK ASSIGNMENT (hereinafter the "Assignment") effective the 26 day of January, 2009 by DataBank, Inc., a Maryland corporation with its principle place of business in Beltsville, Maryland (hereinafter the "Assignor"), and DataBank IMX LLC, a Delaware limited liability company with its principle place of business in Beltsville, Maryland (hereinafter the "Assignee").

RECITALS

WHEREAS, Assignor has adopted, owns and is using the following trademarks for which Assignor owns common-law rights and the following identified federal trademark applications at the United States Patent and Trademark Office for the goods/services identified therein (hereinafter the "Marks"):

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Assignor, Assignor hereby agrees as follows:

Assignor hereby grants, transfers, assigns, sells, conveys and relinquishes exclusively to assignee, its successors and assigns forever, the entire title, right, interest, ownership and all subsidiary rights in and to the Marks, together with the applications for the registrations and all common-law rights of or relating to the Marks, and the goodwill of the business symbolized by and associated with said Marks, including, but not limited to, the following:

(a) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Marks or such associated goodwill;

(b) the right to secure registrations therein in Assignee's own name and to secure renewals and extension of the registrations and applications for registrations in the United States of America or any other country; and

(c) the right to determine, in Assignee's sole discretion whether or not any applications for registration of the Marks shall be preserved and maintained or registered.
