RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS E.D. Smith Limited Partnership, E.D. Smith & Sons, Limited, E.D. Smith USA Inc. and E.D. Smith & Sons, LP (collectively, the "**Grantors**"), the full post office address of whose principal office or place of business is 944 Highway No. 8, Winona, Ontario L8E 5S3, are the owners of certain Canadian, United States, United Kingdom and/or Mexican trade-mark registrations and/or applications, including those listed on Schedule "A" attached hereto (collectively, the "**Trade-Marks**");


AND WHEREAS Bank of Montreal, as agent for itself and certain lenders (the "**Secured Party**") pursuant to the Credit Agreement dated January 23, 2002, pursuant to that certain Intellectual Property Security Agreement dated January 23, 2002, pursuant to the Third Amended and Restated Credit Agreement dated June 2, 2006 and pursuant to that certain Security Agreement (Trade Marks) dated June 5, 2006 (collectively, the "**Agreements**"), was granted a security interest in and to the Trade-Marks;

AND WHEREAS, the Secured Party wishes to: (i) release its security interest covering the Trade-Marks; (ii) restore all right, title and interest in and to the Trade-Marks to the Grantors; and (iii) dissolve any and all liens and encumbrances respecting the Trade-Marks.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release its security interest in the Trade-Marks, and discharges, re-assigns, quit claims and relinquishes unto the Grantors (in each case without recourse and without any representation or warranty) and their respective successors and assigns any and all right, title, interest, benefit and security interest it has in and to the Trade-Marks now covered or intended to be covered by each of the security interests granted by the Grantors to the undersigned including under the Agreements.
