TRADEMARK ASSIGNMENT

WHEREAS, Assignor (as defined below) is the owner of (i) certain imprints, titles, names, trade names, trademarks and service marks (including, without limitation, all registrations thereof and pending applications therefor) used exclusively in the Business (as defined in the Agreement referred to below), including, but not limited to, those listed and described on Schedule 4.09 to the Agreement, along with associated goodwill as provided in the Agreement (collectively, but in each case excluding the PRIMEDIA name or any variation thereof, the "Marks"), and (ii) the Internet domain name www.fedsources.com (the "Domain Name"); and

WHEREAS, PRIMEDIA Information Inc., a Delaware corporation ("Assignor"), and Washington Management Group, Inc., a District of Columbia corporation ("Assignee"), have entered into an Asset Purchase Agreement dated as of October 23, 2003 (the "Agreement"), pursuant to which Assignor has agreed to sell and Assignee has agreed to purchase certain Assets (as defined in the Agreement), including the Marks and the Domain Name, and Assignee has agreed to assume certain liabilities of Assignor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign and transfer unto Assignee, its legal successors and permitted assigns all right, title and interest, whether statutory, registered or at common law, in and to the Marks and the Domain Name, throughout the world, and any renewals or extensions thereof, and all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.


Assignor authorizes and requests the United States Patent and Trademark Office to record Assignee as owner of the Marks, including any renewals and extensions thereof, and to issue any and all trademark registrations of the United States thereon to Assignee, as owner of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors and assigns or other legal representatives, all of the foregoing at the sole cost and expense of Assignee.

In the event of any conflict or inconsistency between the terms, provisions and conditions of this Trademark Assignment and the Agreement, the terms, provisions and conditions of the Agreement shall govern. This instrument shall be governed by the laws of the State of New York (without regard to the conflicts of laws principles thereof or of any other State).

Assignor agrees, at Assignee's expense, to execute any further agreements, instruments and other documents and to perform such other acts as may be necessary and proper to vest all right, title and interest in and to the Marks and the Domain Name in Assignee.
