ACKNOWLEDGEMENT OF ARK II

Ark II Manufacturing, LLC ("Ark II") hereby acknowledges and confirms that:

Pursuant to the First Amended and Restated Credit Agreement (the "Credit Agreement"), dated as of August 15, 2006, among Ark II, Patriarch Partners Agency Services, LLC, in its capacity as agent (the "Administrative Agent"), and ZOHAR CDO 2003-1, Limited, ZOHAR II 2005-1, Limited, ZOHAR III, Limited, and ARK Investment Partners, L.P., (collectively, the "Lenders"), the Lenders made loans to, and made other financial accommodations to or for the benefit of, Ark II (the "Loans").

Pursuant to the related First Amended and Restated Security Agreement (the "Security Agreement"), dated as of August 15, 2006 by Ark II in favor of the Administrative Agent, Ark II granted the Administrative Agent for the benefit of the Lenders and as security for the Loans, security interests in, among other things, substantially all of Ark II's personal property, wherever located, including, without limitation, Ark II's right, title, and interest in and to the following (capitalized terms as defined in the Uniform Commercial Code, as adopted in the States of New York and Illinois, the "UCC"): (i) Equipment and Fixtures, including, without limitation, those items listed on the attached Exhibit 1; (ii) Inventory; (iii) Investment Property; (iv) Accounts; (v) Chattel Paper; (vi) Instruments; (vii) Deposit Accounts; (viii) General Intangibles; (ix) Letter-of-Credit Rights; (x) Negotiable Collateral; (xi) Supporting Obligations; (xii) Commercial Tort Claims; (xiii) all money and Cash Equivalents; (xiv) all intellectual property, including, without limitation, those items listed on the attached Exhibit 2; (xv) the Grantor's books and records; (xvi) Proceeds; and (xvii) all equity interests in Ark de Mexico S.A. de R.L. de C.V. (collectively, the "Collateral").

Pursuant to the Loan and Security Agreement (the "Wachovia Loan Agreement"), dated as of August 15, 2006, among Ark II, Wachovia Capital Finance Corporation (Central) ("Wachovia"), as agent, and the lenders party thereto (the "Wachovia Lenders"), (i) the Wachovia Lenders made loans to, and made other financial accommodations to or for the benefit of, Ark II (the "Wachovia Loans"), and (ii) Ark II granted Wachovia for the benefit of the Wachovia Lenders and as security for the Wachovia Loans, security interests in, among other things, Ark II's right, title, and interest in and to the Collateral.

The Credit Agreement, the Security Agreement and the Wachovia Loan Agreement have been duly executed and delivered to the counterparties by Ark II and each is in full force and effect as of the date hereof, and the obligations of Ark II contained in those agreements constitute legal, binding and valid obligations of Ark II.

As of January 9, 2009, Ark II has (i) outstanding obligations under the Credit Agreement in respect of the Loans in the principal amount of \$78,345,241.44 excluding any accrued or accruing interest, costs or fees, and (ii) outstanding obligations under the Wachovia Loan Agreement in respect of the Wachovia Loans in the principal amount of \$3,253,008.97, excluding any accrued or accruing interest, costs or fees. Accordingly, the Lenders hold secured debt in the total principal amount of \$81,598,250.41.

Events of Default, as such term is defined in the Credit Agreement, the Security Agreement and the Wachovia Loan Agreement, have occurred and are continuing as of the date hereof (the "Existing Defaults").

The Administrative Agent, on behalf of the Lenders, is therefore entitled to immediately exercise its rights and remedies under the Credit Agreement, the Security Agreement and the Wachovia Loan Agreement and under applicable law, including the right pursuant to Section 9-610 of the UCC, and any other applicable law, to sell Ark II's right, title and interests in the Collateral to any person or entity for value.

On August 11, 2008, Ark II received from Wachovia a Notice of Events of Default, Exercise of Certain Remedies and Reservation of Rights to Ark II (the "Wachovia Notice of Events of Default"), notifying Ark II of certain existing events of default and, among other things, reserving Wachovia's other rights and remedies under the Wachovia Loan Agreement and applicable law.

On December 26, 2008, Ark II received from the Administrative Agent a Notice of Events of Default, Acceleration of Obligations, Exercise of Certain Other Remedies and Reservation of Rights (the "Patriarch Notice of Events of Default and Acceleration"), notifying Ark II of certain existing events of default and, among other things, accelerating the amounts due under the Credit Agreement consisting of an unpaid principal balance of the Loans in the amount of \$78,345,241.46 along with accrued interest in the amount of \$1,254,592.26, making them immediately due and payable, and reserving the Administrative Agent's other rights and remedies under the Credit Agreement and applicable law.

The rights of the Wachovia Lenders under the Wachovia Loan Agreement and all other related agreements and instruments (collectively, "Wachovia Financing Agreements") were assigned to one of the Lenders, and Patriarch Partners Agency Services, LLC agreed to act as agent under the Wachovia Loan Agreement, pursuant to that certain Assignment and Acceptance Agreement dated as of December 31, 2008.

The Administrative Agent, for the benefit of itself and the Lenders, has valid, enforceable and perfected security interests in and liens upon the Collateral.

Pursuant to (i) Section 9-610 of the UCC, and any other applicable law, (ii) the Credit Agreement, (iii) the Security Agreement, and (iv) the Wachovia Loan Agreement and Wachovia Financing Agreements, the Administrative Agent, on behalf of the Lenders, exercised its right to foreclose on the Collateral and offered the Collateral for sale to the public at an auction (the "Auction") scheduled for January 10, 2009.

On December 31, 2008, the Administrative Agent, as required by applicable sections of the UCC, served notifications of disposition on Ark II and the other parties required to be notified by law.

Additionally, the Administrative Agent placed advertisements for the Auction in the December 31, 2008 edition of *The Wall Street Journal* and the January 2, 2009 edition of *The New York Times*.

The Administrative Agent, on behalf of the Lenders, conducted an auction for the sale of the Collateral on January 10, 2009 at 10:00 a.m. Central time at the offices of its counsel: Jones Day, 2727 N. Harwood Street, Dallas, Texas 75201.

At the Auction, the Administrative Agent, on behalf of the Lenders, submitted a credit bid for the Collateral in the amount of \$5,000,000. No other bids were submitted at the Auction, and the Administrative Agent's bid was determined the winning bid.
