PARTIAL RELEASE OF TRADEMARK SECURITY INTEREST

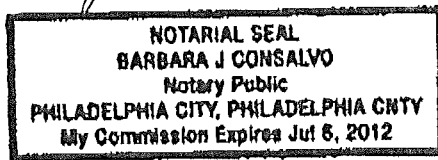
