**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of January 29, 2009, and made by **THE CHASE MANHATTAN BANK, AS COLLATERAL AGENT**, a New York banking corporation, having an office at 200 Jericho Quadrangle, Jericho, New York 11753 ("Grantee") to **TELIGENT, INC.**, a Delaware corporation, **TELIGENT COMMUNICATIONS, INC.**, a Delaware corporation, **TELIGENT TELECOMMUNICATIONS, INC.**, a Delaware corporation, **TELIGENT LICENSE COMPANY I, L.L.C.**, a Delaware limited liability company, **TELIGENT LICENSE COMPANY II, L.L.C.**, a Delaware limited liability company and **ACTUEL, INC.**, a Delaware corporation (collectively, the "Grantors" and each a "Grantor").

WHEREAS, pursuant to that certain Security Agreement dated as of July 2, 1998, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 19, 1998, at Reel 1802 and Frame 0039; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.
2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks.
