TRADEMARK ASSIGNMENT

WHEREAS, ASSIGNOR is willing to transfer to ASSIGNEE that portion of the business of ASSIGNOR to which the Trademarks and Applications pertain and to assign to ASSIGNEE all rights, title and interest as ASSIGNOR may possess in and to the Trademarks and Applications worldwide;

NOW THEREFORE, for good and adequate consideration, in the amount of \$100 for each Trademark Application for a total of \$1,200.00, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns and sells to ASSIGNEE all rights, title, and interest as ASSIGNOR may possess in and to the following:

- (1) The Registered Trademarks set forth in Schedule A; and
- (2) The Intent To Use Applications set forth in Schedule B;

Together with the good will symbolized by said Trademarks and Applications, concurrent with the transfer of that portion of the business of ASSIGNOR to which the Trademarks and Applications pertain. ASSIGNOR also transfers to ASSIGNEE the right to recover for past infringement of the Trademarks.
