NUNC PRO TUNC  
BRANDT FREEFLOW TRADEMARK ASSIGNMENT IN THE UNITED STATES OF AMERICA

This Assignment, effective Nunc Pro Tunc as of March 11, 2005, by and between Varco IP, Inc. ("Assignor"), a corporation of the State of Delaware, having a place of business at 10000 Richmond Avenue, Houston, Texas 77042, and National Oilwell Varco, L.P. ("Assignee"), a limited partnership organized under the laws of the State of Delaware, having a place of business at 7909 Parkwood Circle Drive, Houston, Texas 77036. By this Agreement, Assignor and Assignee agree as follows:

WHEREAS Assignor is the owner of all rights, title, and interest in and to trademark BRANDT FREEFLOW for use in connection with "machines for separating solids and recovering fluid from drilled cuttings and production wastes for use in the oil and natural gas industries", in International Class 7 in the United States of America (hereinafter the "Territory"), including but not limited to application serial no. 77/009,577 for BRANDT FREEFLOW filed in the United States of America on September 28, 2006, together with the goodwill of that portion of the business symbolized by and associated with the foregoing in the Territory, all rights of priority associated with the foregoing in the Territory, and all common law rights in the foregoing in the Territory (the foregoing collectively the "Trademark");

WHEREAS Assignor desires to assign all rights, title and interest in and to the Trademark to Assignee;

WHEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration to it in hand paid, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby sells, assigns, transfers, and conveys to Assignee, its successors and assigns, Assignor's entire right, title, and interest in and to the Trademark, including but not limited to any and all rights and causes of action (including damages recoverable thereby) for past, present, and future unauthorized use of the Trademark, including but not limited to all rights and causes of action for infringement and unfair competition.

Assignor further covenants and agrees that it and its representatives will, at Assignee's request and expense, do all other lawful acts necessary to enable Assignee to obtain, maintain and enforce full the benefits of the rights and interests herein sold, assigned, transferred, and conveyed. This Agreement shall be binding on the successors and assigns of Assignor and shall inure to the benefit of the successors and assigns of Assignee. Assignor represents and warrants that it owns all right, title, and interest in and to the Trademark, that it has the authority to transfer all of the rights sold, assigned, transferred, and conveyed pursuant to this Agreement, and that it has not licensed anyone to use the Trademark in any way. The undersigned hereby represent and warrant that they have the authority to execute this Agreement behalf of their respect entities.

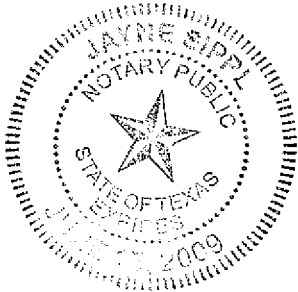
