
WHEREAS, Assignor is the owner of all right, title and interest in and to the Marks set forth on Schedule A; and



1. **Transfer and Assignment.** Assignor hereby transfers and assigns to Assignee all right, title and interest in and to the Marks on a worldwide basis, including but not limited to the registrations set forth on Schedule A, together with the goodwill associated therewith, along with the right to recover for damages and profits and other remedies for past infringements of the Marks.
2. **Further Documentation and Actions.** Assignor hereby agrees to execute and deliver to Assignee any further documents and instruments, and to do any and all further reasonable acts that are deemed necessary by Assignee all right, title and interest in and to the Mark, and to enable such right, title and interest to be recorded in the United States Patent and Trademark Office and any other appropriate governmental authority or agency of the United States and internationally.
3. **Entire Agreement.** This Assignment and the parties' Asset Purchase Agreement represent the entire agreement between the Parties regarding the Marks and supersedes any previous agreement or discussion between the Parties.
