1. GMBH & Co. KG does hereby assign, transfer, grant, convey and set over unto BSN MEDICAL, its successors and assigns throughout the world, all of GMBH & Co. KG's right, title

and interest in and to the Trademark, and any applications and registrations therefor, together with the goodwill of the business symbolized by said Trademark.

2. GMBH & Co. KG agrees to execute and deliver at the request of the BSN MEDICAL, all papers, instruments and assignments, and to perform any other reasonable acts BSN MEDICAL may require in order to vest all GMBH & Co. KG's rights, title and interest in and to the Trademark to BSN MEDICAL.

3. The Effective Date of this assignment shall be April 28, 2006.
