RELEASE OF SECURITY AGREEMENT


WHEREAS, by that certain Trademark Installment Sale Agreement and the Security Agreement, both dated May 28, 1992, RTVCH Holdings, Inc. (hereinafter "RTVCH") granted a security interest in the trademarks listed in Schedule A attached hereto, among other trademarks, to Alan Cohen, in his capacity as Chapter 11 Trustee of Russ Togs, Inc. and Red Horse, Inc. (hereinafter the "Secured Party");

WHEREAS, pursuant to the terms of the Security Agreement, the security interest was to be released once all Secured Obligations (as defined in the Security Agreement) had been performed or discharged in full, including the payment of the full purchase price;
