WHEREAS, said security interest was recorded in the United States Patent and Trademark Office on February 8, 2008 at reel/frame 3716/420.



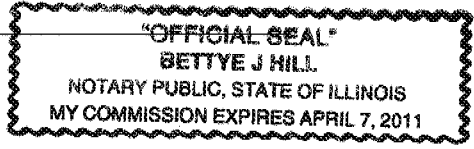


