CERTIFICATE OF AMENDMENT  
OF THE CERTIFICATE OF INCORPORATION  
OF  
MOVEONIN.COM, INC.

UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW

I, the undersigned, Roberta Babitz, being the Chief Executive Officer of MoveOnIn.com, Inc., hereby certify as follows:

1. The name of the Corporation is MoveOnIn.com, Inc.
2. The Certificate of Incorporation was filed by the Department of State on September 7, 1995. The original name of the Corporation was Apartment Source Inc., which name was amended on June 27, 2000.
  3. (a) The Certificate of Incorporation of the Corporation is hereby amended to change the name of the Corporation to Lifetopia Corp.
    - (b) To effect the foregoing amendment specified in paragraph 3(a) above, Article I of the Certificate of Incorporation of the Corporation is hereby deleted in its entirety and replaced with the new Article I, which reads in full as follows:

"FIRST: The name of the corporation is Lifetopia Corp."
4. The foregoing amendment to Article I of the Certificate of Incorporation of the Corporation was authorized (i) by the affirmative vote of the Board of Directors of the Corporation on January 25, 2008, (ii) by the affirmative vote of 66 2/3% of the Series A Convertible Preferred Stock and the Series C Convertible Preferred Stock, voting together as a single class, and (iii) by the affirmative vote of 51% of the shares of the Corporation entitled to vote on the matter.

IN WITNESS WHEREOF, the undersigned has signed this Certificate of Amendment on the 12 day of April, 2008, and hereby affirms the statements contained herein as true under penalty of perjury.
