Amended Trademark Use Agreement

Applicant Los Angeles County Metropolitan Transportation Authority ("LACMTA"), owner of the pending application, Serial No. 78/324860 (the "Application"), to register EZ TRANSIT PASS (the "Mark"), hereby agrees to limit its use, and its licensing and authorization of the use, of the Mark, howsoever it is described or depicted in this Application, or may be described or depicted in any other application, or in any resulting registration, to the forms described in Paragraphs 1 through 3 below, which are partially illustrated in the attached "Examples of Trademark Use". This Amended Trademark Use Agreement supersedes and replaces in its entirety the Trademark Use Agreement recorded on December 22, 2004 in the file of this Application at Reel/Frame 002996/04.


2. IN SERIATIM. The LACMTA may use the Mark in *in seriatim* form (for example, in text or other copy): (a) in the same size as the surrounding text; (b) emphasized compared to the surrounding text, and/or (c) in smaller or larger size than the surrounding text, *provided that* (i) in no event will the Mark be styled such that "transit" is omitted, or used in any form or manner diminished or set off in its appearance as compared to both of "EZ" and "pass", or otherwise differentiated in its appearance from that of "pass", in whatever case or form these other formatives of the Mark ("EZ" and/or "pass") may appear, and (ii) *except, on a limited basis, to conform the appearance or style of the Mark to the appearance or style of the immediately surrounding text when not to do so would be contrary to conventional practice* (such as, without limitation, use within the context of a table of contents or headline), in no event will the *in seriatim* use of the Mark feature initial capitals for "transit" or "pass", all upper case font for "transit"

or "pass", all lower case font, or any italic, oblique or slanted fonts, but rather, will be limited to the specific form "EZ transit pass".


2. STYLIZED. The LACMTA may use, and license or authorize the use of, the Mark as a stylized logo comprised of the letters "EZ" stacked over the combination of words "TRANSIT PASS" in a two-tiered configuration as illustrated by the Examples of Trademark Use, and the Mark, as used in this stylized, two-tiered configuration, may include any or all of the formatives "EZ", "TRANSIT" and/or "PASS" in initial capitals, all lower case font, or all upper case font, and may feature the formative "EZ" in a different font size than that used for the combined words "TRANSIT PASS", but in no event will the Mark in two-tiered configuration include any italic, oblique or slanted fonts or be styled such that "TRANSIT" is omitted, or in any form or manner diminished or set off in its appearance as compared to both of "EZ" and "PASS", or otherwise differentiated in its appearance from that of "PASS", in whatever case or form these other formatives of the Mark ("EZ" and/or "pass") may appear.

2. ALL USES. The LACMTA will not incorporate, and will not license or authorize the incorporation of, a purple color scheme, whether as background, foreground, shading, color of font, or otherwise, in connection with any use of the Mark, irrespective of the form of the Mark.

"The quick brown fox jumped over the EZ transit pass on its way to work.";
