RELEASE OF LIEN ON TRADEMARKS

This RELEASE OF LIEN ON TRADEMARKS (the "Release"), dated as of January 27th, 2009 and effective as of October 27, 2008 is made by JPMORGAN CHASE BANK, N.A., in its capacity as Collateral Agent ("Agent") for the financial institutions party to that certain First-Lien Credit Agreement, dated as of May 24, 2007, among KIK Custom Products Inc. ("KIK"), certain affiliates of KIK party thereto, the financial institutions party thereto and Agent (the "Credit Agreement"), in favor of KIK NEW JERSEY, LLC, a Delaware limited liability company ("Grantor"). Capitalized terms used herein and not otherwise defined shall have the meaning set forth in or incorporated by reference into the Credit Agreement.

WHEREAS, Grantor entered into a Trademark Security Agreement, dated as of November 7, 2007 and recorded in the United States Patent and Trademark Office as of December 6, 2007 at Reel 003672, Frame 0813, pursuant to which Grantor granted to Agent a security interest in and lien on all right, title and interest of the Grantor in certain trademarks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks");

WHEREAS, Grantor has requested that Agent release any and all interest it may have in the Released Trademarks, and Agent has agreed to do so, in connection with a permitted Asset Sale pursuant to Section 6.06 of the Credit Agreement and a subsequent release of Pledged Collateral (as defined in the Security Agreement) pursuant to Section 7.15(c) of that certain First-Lien U.S. Security Agreement, dated as of May 24, 2007, by and among KIK, the guarantors party thereto and Agent (the "Security Agreement").

NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.
