A. As of certain times previous to January 1, 2009, Assignor was the owner of the below three trademark or service mark registrations:

U.S. Service Mark Registration No. 2,688,524 which registered February 18, 2003 for the mark "FE FRONTIER EXPEDITORS (& design)"

U.S. Service Mark Registration No. 2,797,402 which registered December 23, 2003 for the mark "AC ALASKA COMMERCIAL CO. (& design)"

U.S. Service Mark Registration No. 3,048,045 which registered January 24, 2006 for the mark "AC VALUE CENTER"

(all three such trademark or service mark registrations hereinafter singly and jointly referred to as "Service Marks" or the like).

B. Such Service Marks are marks that, from times previous to January 1, 2009, had been used by Assignor in commerce which may be regulated by the U.S. Congress, and which had been developed into a valuable asset that symbolizes and embodies substantial goodwill and consumer recognition in the marketplace.

C. To the extent not already accomplished, Assignor intends by this present document to convey to Assignee the entirety of Assignor's right, title and interest (past, present, and future) (U.S. and foreign) in and to the Service Marks and in and to each individual Service Mark, and in and to all accompanying goodwill and consumer recognition associated with the Service Marks or with each individual Service Mark, all to be effective as of January 1, 2009.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby expressly acknowledged, Assignor does hereby and herewith assign, transfer, sell and convey to Assignee, effective as of January 1, 2009, nunc pro tunc, all of Assignor's right, title, and interest in and to the Service Marks and in and to each Service Mark, together with all goodwill and consumer recognition symbolized by and embodied in the Service Marks or any one of the Service Marks, together with the above noted registrations for the Service Marks.

To the fullest extent of Assignor's right and title, the above assignment, transfer, and conveyance includes any and all causes of action for infringement of the Service Marks or of any one of the Service Marks, past, present, and future, and any and all proceeds from such causes of action accrued and unpaid or hereafter accruing.

Assignor covenants and agrees that it will at any time on request execute and deliver to Assignee any and all documents and papers as may be necessary or desirable to perfect in Assignee the interests herein conveyed, and further covenants and agrees that it will communicate and cooperate with Assignee to the extent necessary for Assignee to have and enjoy to the fullest extent the interests herein conveyed.
