INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment") is entered into this 19th day of April, 2007, by and between Global Home Products, LLC a Delaware limited liability company, Anchor Hocking Operating Company LLC, a Delaware limited liability company, and Anchor Hocking GC Operating Company LLC, a Delaware limited liability company, each a Debtor and Debtor in Possession under Case No. 06-10340 (KG) in the United States Bankruptcy Court for the District of Delaware (each an "Assignor" and together the "Assignors") and Anchor Acquisition, LLC, a Delaware limited liability company ("Assignee"). Capitalized terms not defined herein have the meanings given such terms in the Purchase Agreement.

WHEREAS, Assignors and Assignee entered into that certain Asset Purchase Agreement (the "Purchase Agreement"), dated as of March 6, 2007, as amended March 10, 2007 and March 23, 2007, pursuant to which Assignors agreed, to the extent of their respective right, title and interest in the Assigned Intellectual Property (as defined below), to sell, convey, assign, transfer and deliver to Assignee all right, title and interest in, to and under all Intellectual Property owned by the Assignors, including, without limitation, the Intellectual Property set forth on Annex A hereto (collectively, "Assigned Intellectual Property"); and

WHEREAS, this Assignment is made in connection with the sale of substantially all of the assets of the business to which the Assigned Intellectual Property relates and such business is ongoing.

NOW, THEREFORE, in consideration of the mutual covenants, agreements and warranties herein contained, and for other good and valuable consideration set forth in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged by Assignor, Assignor and Assignee hereby agree as follows:

1. 1. To the extent of their respective right, title and interest therein, each Assignor hereby sells, conveys, transfers, assigns and delivers to Assignee any and all right, title and interest in, to and under all the Assigned Intellectual Property, along with all goodwill associated therewith and the business symbolized thereby, all income, royalties, products, proceeds, damages and payments due or payable to Assignor, including, without limitation, damages and payments for past, present or future infringements, misappropriations or other causes of actions thereof, the right to sue and recover for past infringements, misappropriations or other causes of actions thereof and any and all corresponding rights that, now or hereafter, may be secured throughout the world and all copies and tangible embodiments of any such Assigned Intellectual Property in Assignors' possession or control.

2. Assignor shall, at Assignee's request, take any such further reasonable actions, and provide Assignee, and Assignee's successors, assigns or other legal representatives, reasonable cooperation and assistance (including, without limitation, the execution and delivery of all confirmatory assignment deeds, change of name or address certificates and any other instrument, document and agreement reasonably requested,

such as affidavits, declarations, oaths, assignments, powers of attorney or other documentation) as reasonably necessary or reasonably requested by Assignee to more fully and effectively effectuate the purposes of this Assignment.

3. This Assignment is irrevocable and shall be effective as of the date first above written.

4. Assignor hereby authorizes the United States Patent and Trademark Office and/or any other appropriate U.S. or foreign governmental agency to deliver to Assignee, and to Assignee's attorneys, agents, successors or assigns, all registrations, renewals and recordation certificates, and other documents and communications relating to the Assigned Intellectual Property as may be warranted by this Assignment.

5. This Assignment supplements and is in addition to all other rights of the Assignee under the Purchase Agreement and other instruments of transfer delivered in connection with the Purchase Agreement. To the extent there is a conflict between the terms and provisions of this Agreement and the Purchase Agreement, the terms and provisions of the Purchase Agreement will govern.

6. All issues and questions concerning the construction, validity, enforcement and interpretation of this Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware without giving effect to any choice of law or conflict of law rules or provisions.

7. This Assignment may be executed in counterparts (including, without limitation, by means of facsimile signature pages), any one of which need not contain the signatures of more than one party, but all such counterparts taken together shall constitute one and the same agreement.


