**ASSIGNMENT OF TRADEMARK RIGHTS**

THIS AGREEMENT is effective as of the 31<sup>st</sup> day of July 2008 ("Effective Date"), by and between Harrow Sports, Inc., a Colorado corporation having its principal place of business at 600 West Bayaud Avenue, Denver, Colorado 80223 ("Harrow"); and Christian Hockey, LLC, a Minnesota limited liability company having its principal place of business at 1082 Third Street NW, Roseau, Minnesota 56751 ("Christian").

WHEREAS, Harrow is the owner of the registered and unregistered trademarks and service marks and domain name on a worldwide basis set forth in Schedule A (hereinafter collectively "Trademark Rights"); and

WHEREAS, Christian bought certain hockey-related business assets, including the Trademark Rights, from Harrow by means of a July 31, 2008 Asset Purchase Agreement, and the Parties are desirous of reconfirming the assignment of the Trademark Rights for purposes of recording them in various Trademark Offices around the world.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Harrow does hereby sell, assign, and transfer to Christian, as of the Effective Date, all right, title and interest of Harrow in and to such Trademark Rights, together with the good will of the business symbolized by the Trademark Rights, and all claims for damages arising out of or relating to past or continuing infringement thereof, if any, the same to be held by Christian, for its own use and enjoyment, and for its legal representatives and assigns, to the full end of the term for which any applicable trademark registration is granted, as fully and entirely as the same would have been held by Harrow had this assignment and sale not been made.

IN WITNESS WHEREOF, the Parties have caused this Agreement to be executed through their duly authorized and empowered representatives as of the Effective Date.



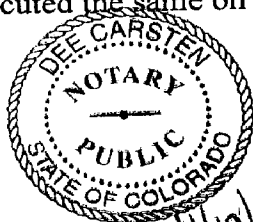
