NUNC PRO TUNC INTELLECTUAL PROPERTY ASSIGNMENT

This Nunc Pro Tunc Trademark Assignment (this "Nunc Pro Tunc Assignment") is made and entered into as of this 17th day of February, 2009, with an effective date of 30 November 2006, by and between Jas. D. Easton, Inc., a California corporation, having a business address of 7855 Haskell Avenue, Suite 202, Van Nuys, CA 91406 ("Assignor"), and Jas. D. Easton, Inc., a Delaware corporation, having a business address of 5040 West Harold Gatty Drive, Salt Lake City, UT 84116, ("Assignee").

WHEREAS, Assignor adopted, used, and was using the marks listed on Schedule A hereto, which are registered with the U.S. Patent and Trademark Office (USPTO) (the "Marks"); and

WHEREAS, Assignee is desirous of acquiring all of Assignor's right, title and interest in and to the Marks and the goodwill associated therewith, as well as any corresponding U.S. trademark registrations;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which Assignor acknowledges:

1. Assignor hereby assigns, transfers, and quitclaims to Assignee all of its right, title, and interest in and to the Marks, including common law trademark rights as well as any corresponding U.S. trademark registrations; together with the goodwill of the business symbolized thereby, and all causes of action for infringement thereof, and any and all royalties for any licenses thereof (collectively, the "Assets").

2. Assignor agrees that the Assets as defined herein include all of Assignor's right, if any, to sue, bring actions for, and recover and hold damages, profits and other compensation for any and all past and future infringements and unauthorized uses of the Assets.

3. The Assignor also hereby covenants and agrees that the Assignor shall, at the request of Assignee or its counsel and at Assignee's cost, risk, and expense, execute, acknowledge, and deliver all such further acts, deeds, assignments, transfers, powers of attorney, and assurances as may be required to carry out the intent of this Nunc Pro Tunc Assignment, and to transfer and vest all of Assignor's right, title, and interest to and in the Assets and to procure, maintain, enforce and protect such right, title and interest; provided, however, this Nunc Pro Tunc Assignment shall be effective regardless of whether any such additional documents are executed.

4. This Nunc Pro Tunc Assignment shall be binding upon Assignor, Assignor's successors and assigns.
