THESE ARTICLES OF AMENDMENT of the Articles of Incorporation of Pyramid Breweries Inc., a Washington corporation, are executed and delivered for filing in accordance with the provisions of Section 23B.10.060 of the Washington Business Corporation Act:

1. The name of the corporation is Pyramid Breweries Inc.
2. Article 1 of the Articles of Incorporation of the corporation is hereby amended to read as follows:

**ARTICLE 1**

**Name**

The name of the corporation is Independent Brewers United Corporation.

3. The above amendment was adopted on December 16, 2008.
4. The effective date of the Articles of Amendment is January 1, 2009.
5. The above amendment was duly approved by the Board of Directors of the corporation, without shareholder action, in accordance with the provisions of Section 23B.10.020(5) of the Washington Business Corporation Act. Shareholder action was not required to effect this amendment.
