Assignor hereby conveys to Assignee all income, royalties, and damages hereafter due or payable to Assignor with respect to the Trademarks, if any, including without limitation, damages, and payments for past or future infringements and misappropriations of the Trademarks; and all rights to sue for past, present, and future infringements or misappropriations of the Trademarks.

Assignor authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registrations and/or applications for registration set forth on Exhibit 1 to Assignee as assignee of Assignor's entire right, title and interest therein.
