DEED OF ASSIGNMENT

THIS ASSIGNMENT is made the 26th day of JANUARY 2009 2008

BETWEEN

Rubicon Drinks Limited, a company organised under the laws of the United Kingdom, of Rubicon House, Second Way, Wembley, Middlesex, HA9 0YJ ("the Assignor"), of the one part

AND

Lanara Limited, a company organised under the laws of Cyprus, of City House, 6 Karaiskakis Street, Limassol, CY-3032, Cyprus ("the Assignee"), of the other part.

WHEREAS

- A. *The Assignor is the owner of US Trade Marks Nos. 2,090,926 RUBICON and 2,602,951 SUN EXOTIC ("the Marks");*
- B. *The Assignor has no further use for the Mark;*


C. It was agreed by the parties hereto that the rights in the Mark would be transferred to the Assignee with effect from 29th August 2008;

NOW THIS DEED WITNESSETH as follows:

In consideration of the premises and the sum of \$1, the receipt whereof is hereby acknowledged, the Assignor hereby assigns unto the Assignee with effect from 29th August 2008 and with full title guarantee to the Assignee all that the property, right, title and interest in and to the Marks in respect of all the goods for which they are registered, together with the whole of the goodwill associated with or related to the Marks, together also with all common law rights in the Marks and all accrued causes of action, to hold same unto the Assignee absolutely.
