Assignor represents and warrants that he has not previously transferred or otherwise encumbered the rights being assigned to Assignee herein.



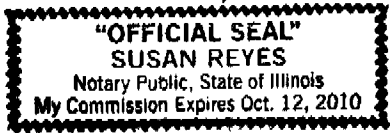
