NOTICE OF TRADEMARK SECURITY AGREEMENT
(FOR RECORDATION PURPOSES)

This Notice of Trademark Security Agreement, dated as of February 12, 2009, is made with regard to NORTH AMERICAN BISON COOPERATIVE, a North Dakota cooperative, whose address and principal place of business is 1658 Highway 281, New Rockford, North Dakota 58356 (the "Debtor"), by FIRST BUSINESS CAPITAL CORP., a Wisconsin corporation, whose address and principal place of business is 401 Charnany Drive, Madison, Wisconsin 53719 (the "Secured Party").

R E C I T A L S:

The Debtor and the Secured Party have entered into a Loan and Security Agreement dated as of February 12, 2009 (as the same may hereafter be amended, supplemented or restated from time to time, the "Loan Agreement"), setting forth the terms on which the Secured Party may now or hereafter make certain loans or other financial accommodations to or for the account of the Debtor.
