**CONFIRMATORY ASSIGNMENT AGREEMENT OF
WORLDWIDE INTELLECTUAL PROPERTY**

This Confirmatory Assignment Agreement of Worldwide Intellectual Property rights ("Confirmatory Assignment"), effective January 31, 2008, ("Effective Date") is by and between Yanni Partners, Inc., a Pennsylvania corporation with its principal place of business at 310 Grant Street, Pittsburgh, Pennsylvania 15219 ("Assignor") and GBS Investment Consulting, LLC, a Delaware limited liability company, with its principal place of business at 2711 Centerville Road, Suite 400, Wilmington, Delaware 19808-1645 ("Assignee").

WHEREAS, Assignee desires Assignor now to confirm said sale, conveyance, assignment, and transfer insofar as it relates to said Intellectual Property and all goodwill of the business symbolized by the marks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor, hereby confirms that effective January 31, 2008, it sold, conveyed, assigned, transferred, and delivered to Assignee, its successors, assigns and legal representatives, all worldwide right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized thereby, and in all Copyrights, with all rights to sue for past infringement of said Trademarks and Copyrights, and all causes of action (either at law or equity) with respect thereto, the right of recovery, including but not limited to damages, for such past infringement, and the right to assign the rights conveyed herein, the same to be held and enjoyed by Assignee for its own use and benefit and for the use and benefit of its successors, assigns and legal representatives.

Assignor will from time-to-time after the Effective Date, upon request of Assignee, execute, acknowledge, and deliver all such further deeds, assignments, transfers, conveyances, powers of attorney and assurances, and take such further action as may be required to carry out the intent of this Confirmatory Assignment, and to transfer and vest title to any trademark or copyright being transferred

hereunder, and to protect the right, title, and interest in and enjoyment of all the Trademarks and Copyrights assigned hereunder.
