TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") is entered into by and between Web.com Holding Company, Inc., a Delaware corporation ("Assignor") and Trellix Corporation, a Delaware corporation ("Assignee"), and is made with respect to the following recitals and is made effective September 16, 2008.

WHEREAS Assignee has been a wholly owned subsidiary of Assignor or its predecessors in interest since 2003.

WHEREAS Assignee has used the mark TRELLIX (the "Trademark") as a trademark and has thereby obtained goodwill in the Trademark, has owned the ongoing and existing business related to the Trademark, and owns US Trademark Registration No. 2335938 for the mark TRELLIX WEB.

WHEREAS Assignor has applied for registration of the Trademark, namely US Trademark Application No. 77/344,961 for TRELLIX ("the Assignor Application").

In consideration of the premises, mutual covenants and agreements contained in this Agreement, the parties agree as follows:

Terms and Conditions

1. Assignor hereby sells, assigns and transfers to Assignee all of Assignor's right, title and interest in and to the Trademark in any typeface, stylization, colors, and/or capitalization, and any US state, federal or foreign applications and registrations of the foregoing, including the Assignor Application, including the goodwill associated therewith (altogether, the "Assignor Trademark Rights").
2. To the extent that Assignor has any right, title or interest in the Assignor Trademark Rights, Assignor hereby sells, assigns and transfers them to Assignee. Assignor will execute any documents reasonably necessary to effect the transfer of its Assignor Trademark Rights (if any) to Assignee.
3. Assignor acknowledges receipt of adequate consideration.
4. The parties hereto are separate and independent legal entities. Nothing herein contained will be construed or deemed hereby to create a principal/agent relationship between the parties nor any form of partnership or joint venture.
