TRADEMARK ASSIGNMENT

NOW THEREFORE, for and in consideration of the mutual covenants and undertakings of the parties, the receipt and sufficiency of which is hereby acknowledged, and in further consideration of the sum of US \$10.00, the receipt whereof the ASSIGNOR hereby acknowledges; the ASSIGNOR, as proprietor, HEREBY ASSIGNS unto the ASSIGNEE all rights, title and interest in and to the Mark together with the goodwill of the business in the goods in respect of which the Mark is registered to hold unto the ASSIGNEE absolutely. This assignment constitutes a transfer of all of ASSIGNOR's right, title and interest in the Mark.




