RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby releases its security interest in the Trademarks, including any renewals thereof, and all rights relating thereto, and reassigns to Borrower any and all rights in such Trademarks held by Lender, without recourse, representation or warranty.


