RELEASE OF NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

Release of Notice of Grant of Security Interest in Trademarks (this "Release"), dated as of the 13th day of February, 2009, made by **Bank of America, N.A., as Collateral Agent**, (hereinafter the "Administrative Agent"), in favor of **Take-Two Interactive Software, Inc.** (hereinafter the "Pledgor").

R E C I T A L S

A. The Pledgor and Administrative Agent entered into a certain Notice of Grant of Security Interest in Trademarks, dated as of **August 28, 2002** and recorded with the United States Patent & Trademark Office on **October 21, 2002** at **Reel 2604, Frame 0657** (the "Agreement"); capitalized terms used herein and not defined shall have the meanings set forth in the Agreement, pursuant to which the Pledgor granted to Administrative Agent a lien on and security interest in certain Trademark Collateral owned by the Pledgor.

B. In accordance with the terms of the Agreement, the Pledgor has satisfied all of its outstanding obligations under the Agreement and, in connection therewith, the Pledgor has requested Administrative Agent to release, and Administrative Agent has agreed to release, its lien on all trademark collateral pledged pursuant to the Agreement.

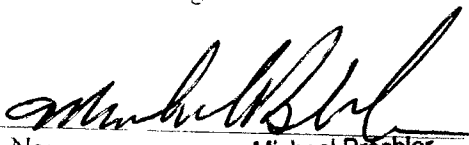
A G R E E M E N T
