TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") is entered into as of this 9th day of September, 2008 by and among First National Business Corporation, a Missouri corporation, having an principal place of business at 1335 E Republic Road, Suite K, Springfield, MO 65804 ("Assignor"), and USBB, L.L.C., a Missouri limited liability company, having its principal place of business at [14201 E. Kentucky Road, Independence, MO 64050] ("Assignee").

WHEREAS, Assignor owns federal trademark registrations, as set forth in United States Patent and Trademark Office, for the following marks: FIRST NATIONAL BUSINESS CORPORATION (Registration No. 3482229), FNBC (Registration No. 3459481) and FNBC (Registration No. 3156471) (the "Registered Marks") (as set forth on Exhibit A), and Assignor has, on its own, or through certain of its affiliates, adopted, used and is using the Registered Marks;

WHEREAS, Assignor is presently affiliated with MUSBB, Inc., which was formerly known as and has previously done business as United States Business Brokers, Inc.;

WHEREAS, Assignor may have common law trademark rights as a result of Assignor's affiliation with MUSBB, Inc. in the following common law trademarks: UNITED STATES BUSINESS BROKERS, USBIZCORP, USBB, USFRANBIZ, USM&A, FIRSTBIZ, and TELESPOUND USA (the "Common Law Marks") (as set forth in Exhibit A), and Assignor has, on its own, or through certain of its affiliates, adopted, used and is using the Common Law Marks;

WHEREAS, Assignor is assigning its entire right, title and interest in the Registered Marks and Common Law Marks in fulfillment of MUSBB, Inc.'s obligations under the Asset Purchase Agreement, dated September 9, 2008, between MUSBB, Inc. (known at the time of the Asset Purchase Agreement as United States Business Brokers, Inc.) and Assignee;

WHEREAS, Assignor wishes to assign to Assignee all of Assignor's right, title and interest in the use of the Registered Marks, and quit-claim assign all of Assignor's right, title and interest in the use of the Common Law Marks subject to the terms and conditions hereof; and

WHEREAS, Assignee desires to acquire the entire right, title and interest in and to said Registered Marks, the quit-claim right, title and interest in and to said Common Law Marks and the related registrations or applications (collectively, the "Trademark Rights").

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. In consideration for the respective obligations of Assignee and MUSBB, Inc. (who is affiliated with Assignor) and the additional consideration of ten dollars (\$10.00) payable upon execution of this Agreement by Assignee to Assignor, Assignor hereby sells, assigns, transfers and sets over unto Assignee all of Assignor's right, title and interest in and to the Trademark Rights in the Registered Marks, together with that portion of the goodwill related to the Trademark Rights connected with the use of and symbolized by the Registered Marks included in the Trademark Rights and the know how associated with and necessary to control the nature and quality of goods associated with the Registered Marks, and all causes of action, past, present and future for infringement of the Trademark Rights.

2. Assignor further sells, assigns, transfers and sets over unto Assignee all of Assignor's right, title and interest in the Trademark Rights to the extent applicable in the Common Law Marks, together with that portion of the goodwill related to the Trademark Rights connected with the use of and symbolized by the Common Law Marks included in the Trademark Rights and the know how associated

with and necessary to control the nature and quality of goods associated with the Common Law Marks, and all causes of action, past, present and future for infringement of the Trademark Rights.

3. Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect the title to the Trademark Rights in Assignee, its successors and assigns, and that it will, at any time upon request, communicate to Assignee, its successors and assigns, such facts relating to the Trademark Rights or the history thereof as may be known to it.
