**CONDITIONAL ASSIGNMENT
OF
TRADEMARKS**

WHEREAS, TARGUS GROUP PLC, a company incorporated under the laws of England and Wales and domesticated under the General Corporation Law of the State of Delaware with its major executive office in the United States located at 654 Madison Avenue, Suite 703, New York, New York 10022 (the "*Grantor*"), has adopted, used and owns the United States trademarks more particularly described on Exhibit A attached hereto (each a "*Trademark*"), which are registered in the United States Patent and Trademark office; and

WHEREAS, pursuant to a certain Credit Agreement dated as of January 18, 1996 (the "*Credit Agreement*") among Targus Inc., a New York corporation, Targus Group International, Inc. a Delaware corporation (each a "*Borrower*"), the lenders from time to time parties thereto (the "*Lenders*") and BHF-Bank Aktiengesellschaft, acting through its New York branch, as agent for the Lenders hereunder (in such capacity, for the benefit of the Lenders, the "*Grantee*"); and

WHEREAS, in order to secure obligations from time to time owing by the Borrowers to the Grantee and the Lenders under the Credit Agreement, the Grantor and the Grantee have entered into a Trademark Security Agreement dated as of January 18, 1996 (the "*Security Agreement*");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor does hereby conditionally assign to the Grantee, and grant unto the Grantee, a continuing security interest in, all right, title and interest of the Grantor in and to the Trademarks and the applications and registrations thereof, together with the goodwill of any business connected with the use of, and symbolized by, such Trademarks, and all proceeds thereof, including, without limitation, any and all causes of action for dilution or infringement thereof and any and all royalties for any licenses thereof (collectively, the "*Collateral*"), to secure the prompt payment, performance and observance of the Obligations (as such term is defined in the Security Agreement).

The Grantor hereby further acknowledges and affirms that the rights and remedies of the Grantee with respect to the assignment of, and security interest in, the Collateral made, and granted, hereby are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated by reference as if fully set forth herein.


