WITNESSETH:


WHEREAS, Assignor owns the trademarks and service marks identified in Schedule A hereto (collectively, the “Marks”); and

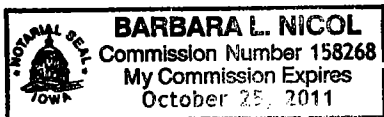


