RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of July 21, 2008 ("Effective Date") by and between Bix Enterprises, Inc., a Delaware corporation, with an office at 200 Westerly Road, Bellingham, Washington 98226 ("Grantor"), and Freeport Financial, LLC, a Delaware limited liability company with an office at 500 W. WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement among Homax Products, Inc., Grantor, The Gonzo Corporation, Jasco Chemical Corp., Magic American Products, Inc., Osmegen Incorporated, Rhodes*American Products, Inc., Stone Care International, Inc., Site-B Company and Grantee dated November 2, 2006, Grantor granted to Grantee a security interest in and to the trademarks set forth on Schedule A attached hereto together with all goodwill of the business connected with the use of, and symbolized by, each such trademark (collectively, the "Trademarks");

WHEREAS, the security interest was recorded with the United States Patent and Trademark Office at Reel 3423, Frame 0172 on November 7, 2006;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates, cancels and releases any and all security interests it has against the Trademarks.


