RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of July 21, 2008 ("Effective Date") by and between Jasco Chemical Corp., a California corporation, with an office at 200 Westerly Road, Bellingham, Washington 98226 ("Grantor"), and General Electric Capital Corporation, a Delaware corporation, with an office at 500 W. WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement among Homax Products, Inc., Bix Enterprises, Inc., The Gonzo Corporation, Grantor, Magic American Products, Inc., Osmegen Incorporated, Rhodes*American Products, Inc., Stone Care International, Inc., Site-B Company and Grantee dated November 2, 2006, Grantor granted to Grantee a security interest in and to the trademarks set forth on Schedule A attached hereto, together with all goodwill of the business connected with the use of, and symbolized by, each such trademark (collectively, the "Trademarks");

WHEREAS, the security interest was recorded with the United States Patent and Trademark Office at Reel 3422, Frame 0453 on November 6, 2006;


