EXHIBIT A**TRADEMARK ASSIGNMENT AGREEMENT**

This TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment Agreement"), entered into as of February 27, 2009, (the "Effective Date"), is made by and between Love Rocks by JAGS, Ltd., a Texas limited partnership ("Assignor") and TXDC, L.P., a Texas limited partnership ("Assignee").

WITNESSETH:

WHEREAS, Assignor has adopted and used various trademarks and/or service-marks including the term "Love Rocks," including but not limited to the LOVE ROCKS BY JAGS & Design trademark (U.S. Reg. No. 3,565,444), other pending trademark and/or service-mark applications for such mark or any mark containing the term "Love Rocks," and/or other common-law marks incorporating the term "Love Rocks" (the "Marks");

WHEREAS, Assignor has agreed to assign and Assignee has agreed to acquire all of Assignor's right, title and interest in and to the Marks, both registered and common-law, the goodwill of the business symbolized thereby, and the right to recover damages and profits for infringement thereof occurring on or after the date of this Assignment; and

NOW, THEREFORE, in consideration of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers and conveys unto Assignee all of Assignor's right, title and interest in and to the Marks, both registered and common-law, the goodwill of the business symbolized thereby, and the right to recover damages and profits for infringement thereof occurring on or after the date of this Assignment. The rights of the parties with respect to damages and profits for infringement occurring before the date of this Assignment Agreement are set forth in the February 27, 2009 Settlement and License Agreement to which Assignor and Assignee are parties.
2. Assignor represents and warrants that it is the exclusive owner of the entire right, title and interest in and to the Marks, that it has the full right and authority to enter into this Assignment Agreement and that there are no outstanding liens against the Marks.
3. This Agreement shall be governed by and construed in accordance with the laws of the United States of America and of the State of Texas.
