**NOW, THEREFORE, the Secured Party does hereby release and terminate its entire right, title and interest in and to said Security Agreement and the security interests granted therein and identified herein as to all the Trade-marks as filed and registered with the United States Patent and Trademark Office in Washington, D.C.**
